The objectives of the study (Specifically, the study aims to ascertain the influence of organizational, technology, leadership and resource acquisition on performance of mission hospitals in Kiambu County.</li> <li>iii. Methodology employed (No mention was made of the statistical tools like the regression technique and ANOVA used in the abstract)</li> <li>iv. Major findings</li> <li>v. Recommendations</li> </ol> <p>Like the title of the study, the abstract has some punctuations and grammatical errors. Apart from my comments, the areas marked red in the work are some the corrections made by me. They may not remain after you recast your abstract.</p>	
<b>3. There are few grammatical errors and spelling mistakes in this article.</b>	<b>3</b>
<p>I have highlighted a number of grammatical errors and spelling mistakes in this article for your correction. You can find them in the abstract and body of the article.</p>	
<b>4. The study methods are explained clearly.</b>	<b>3</b>
<ol style="list-style-type: none"> <li>i. No mention was made in the abstract of the statistical tools like the regression technique and ANOVA used in the study.</li> <li>ii. There is no econometric or mathematical model of the variables in the methodology to show the cause and effect relationship of the variables used in the study.</li> </ol>	
<b>5. The body of the paper is clear and does not contain errors.</b>	<b>3</b>

The last sentence in the background of study should be taken to methodology where proxies for the various independent variables and dependent variable are operationalized.</li> <li>ii. Carefully edit the manuscript to address some structural errors.</li> <li>iii. The statement of problem should start with the authors' perceived problem or public outcry that necessitated the study and not a problem cited from another author's work that was cited way back in 2016.</li> <li>iv. As a guide, the statement of problem should address the following questions: what is the perceived problem or public outcry that necessitated the study, how topical and recent is the problem, what literature gap does this study intend to cover or what has related studies failed to do that this study intend to address.</li> </ol>

The connection between conclusions and results are not clear. Results contain numbers and values from SPSS, but the these values don't refer to the conclusions clearly.</i>

<i>Please show KSH in parenthesis in page 3.</i> <i>It should be considered to write about 2 sentences about Ogollah's result, because it is not clear why important the matching of the current result with his results</i> <i>It would be appreciated to check the ESJ requirements of the figure and table identification, and how to refer to figures and tables in body text</i>	
<b>6. The conclusions or summary are accurate and supported by the content.</b>	<b>4</b>
<i>The last paragraph mentions any point of competence increasing, but there is no information where this recommendation comes from.</i>

APA requirement should check again Moulli (2011) on the page 2. does not exist in the reference list at the end of the paper</i> <i>Raquel Muigai on page 3.is not consistent with given in the references list</i> <i>On page 3. also Consumer Federation of Kenya are also a references, should be visible in the reference list</i> <i>Check Robbi &amp; DeCenzo on page 4. and in the reference list also (Robbins, Stephen P./ De Cenzo, David A.)</i> <i>Please check Northouse's name and data in the reference list</i> <i>Gakenia (2015) on page 7 is missing from reference list</i> <i>Gitahi, A. page 1 is abstract – OK

page 2 is introduction – OK

page 3-8 is literature – MUCH

page 9 is research methodology – can be enough but ask the following question: What do you examine with regression? Why you have chosen the regression? (a few sentences)

page 10-13 – research findings (2,5 pages) could be more

page 13-14 – conclusions (1.5 pages) can be OK

Feel the rates. Literature size is maximum equal with the research introduction size, but don't be more, rather less.
