1. The title is clear and it is adequate to the content of the article.	3

The title is long and redundant. It could be simplified by: «The Tchologo Regional Council facing the challenge of access to water and electricity in the department of Kong (North of the Ivory Coast)».

2. The abstract clearly presents objects, methods and results.	2

Le résumé mérite d'être mieux structuré. Objectif général insuffisamment précis, Objectif spécifique 3 nous semble inapproprié. Méthode à mieux clarifier. Résultats bien présents conformément à la vision de l'auteur.

The summary deserves to be better structured. General objective insufficiently precise, Specific objective 3 seems inappropriate to us. Method to be better clarified. Results well present according to the vision of the author.

3. There are few grammatical errors and spelling mistakes in this article.	4

Si le texte contient relativement peu d'erreurs grammaticales rendant sa lecture aisée, l'auteur gagnerait à simplifier son langage qui frise le pédantisme.

If the text contains relatively few grammatical errors making it easy to read, the author would benefit from simplifying his language that borders on pedantry.

4. The study methods are explained clearly.	2

L'introduction de l'auteur n'en est véritablement pas une. L'état des lieux des écrits qui pullulent sur cette question est très plat. Même si le nombre d'auteurs convoqués ne confère pas forcement la qualité de l'idée, en avoir seulement deux pour une telle problématique nous semble trop insuffisant. L'introduction mérite une refonte.

La méthodologie souffre d'éléments pertinents. La zone d'étude est très sommairement présentée. La justification des personnes ressources est inexistante. Les populations bénéficiant des actions de développement ne sont pas consultées pour l'appréciation desdites actions.

The author's introduction is really not one of them. The state of play of the writings that abound on this issue is very flat. Even if the number of authors summoned does not necessarily confer the quality of the idea, having only two for such a problem seems too insufficient. The introduction deserves a redesign.

The methodology has relevant elements. The study area is very succinctly presented. There is no justification for contacts. The populations benefiting from development actions shall not be consulted for the assessment of those actions.

5. The results are clear and do not contain errors.	3

Les résultats annoncés par l'auteur y sont. Cependant, le déficit de leur pertinence réside en la convocation des actions de l'action publique. L'étude aurait dû

ressortir les contraintes des acteurs décentralisés. L'étude aurait dû mettre en relief le niveau de satisfaction des populations.

The results announced by the author are there. However, the deficit of their relevance lies in convening the actions of public action. The study should have highlighted the constraints of decentralized actors. The study should have highlighted the level of satisfaction of populations.

6. The conclusions or summary are accurate and supported by the content.

Les idées de la sections « discussion » sont à mieux structurer. L'auteur fait une juxtaposition d'idées pas forcement liées en loin des résultats de l'étude. Il avance des résultats qui n'apparaissent nullement dans le texte, ou y apparaissent très insuffisamment. C'est le cas des contraintes des autorités décentralisées et de celui du niveau de satisfaction des populations.

Ideas in the discussion section need to be better structured. The author makes a juxtaposition of ideas not necessarily related away from the results of the study. He advances results that do not appear in the text, or appear very insufficiently. This is the case with the constraints of the decentralized authorities and the level of satisfaction of the populations.
