#### The study METHODS are explained clearly.

The Method in the Abstract states that a sample of 84 respondents was selected using a stratified random sampling method to ensure representation in all strata. The population of the study is also stated to be all employees of the National Development Bank in Botswana.

However, the main method of the study, states that the researchers used a probabilistic stratified random sampling method and selected a total of 32 respondents for the study. This number is significantly lower than the sample size mentioned in the Abstract.

It is possible that one of these contains an error or that they are referring to different aspects of the study. However, as they currently stand, they appear to be contradictory and require clarification or correction.

The research design used in the study provides readers with a clear understanding of how the researcher collected and analyzed data to explain the perceptions of bank employees regarding anti-money laundering practices in their organization.
