The title is clear, unambiguous, and consistent with the content of the text. It is concise, as it	
presents only one object of study (interstate marriage between native	es and non-natives in the

presents only one object of study (interstate marriage between natives and non-natives in the border area). However, it contains a grammatical error: the author placed a period at the end of the title. Since a title is not a complete sentence, it should not end with a period.

### 2. The abstract presents objects, methods, and results.

The abstract presents the context and the object of the study (a comprehensive examination of cross-border marriage in the southern and northern regions of Cameroon). It mentions the methodological approach, a qualitative study based on observation and interviews. Moreover, it specifies the theoretical framework of analysis (the theory of neo-regionalism) and highlights the key elements of the findings.

## 3. There are a few grammatical errors and spelling mistakes in this article.

The article is generally well written; the sentences are clear and unambiguous. However, there are some formal errors, such as the omission of the authors' names and the publication dates in the various tables and illustrations, which must be corrected by the author.

#### 4. The study methods are explained clearly.

The methodology contains irregularities at several levels. The section corresponding to "Methods" in the IMRAD structure is retitled by the author as "Data Collection Methods." At this point, a confusion arises because, in the IMRAD framework, the "Methods" section should include the sampling methods and techniques as well as the theoretical framework through which the study data will be analyzed. The author mentioned the analytical theory "neo-regionalism" in the introduction, whereas it should have been presented and explained in the "Methods" section. The author should specify the founding scholar of this theory and, most importantly, explain how it serves as a framework for analyzing the study's data. In addition, this section should outline the structure adopted for presenting the research results. Moreover, the author does not specify the types of observation (participant or direct) and interviews (structured, semi-structured, or open) used in the study, as required by the conventions of qualitative research.

#### 5. The results are clear and do not contain errors.

the results lack survey data typical of the qualitative approach adopted in this study. The interviews should include verbatim excerpts or diagrams that support the arguments developed in each section. Observation should also be complemented by photographs of meaningful scenes. Only one verbatim excerpt was identified in the text, which is clearly insufficient for a qualitative study focusing on a social phenomenon such as marriage.

# 6. The conclusions or summary are accurate and supported by the content.

The conclusion addresses the summary of the research findings, the methodological review, the theoretical assessment, and the lessons learned from the study. In light of these elements, the conclusion meets the required standards and is well written.

#### 7. The references are comprehensive and appropriate.

The bibliography is excessive and does not reflect all the citations contained in the document. Furthermore, it contains irregularities in punctuation. It is advised to put a period/full stop at the end of each bibliographic reference. Above all, the title 'Bibliographic References' (or 'References') is the most suitable for this type of exercise (only the authors cited in the document should appear in the bibliographic references).

from their logical framework of analysis. They must lead the discussion around the key points of the results. The discussion presented is insufficient and lacks depth in the analysis. It uses the same volume of writing as the conclusion
